5. Do you use Multi-Entity management from Binary Stream and need to indicate entities on your payment remittances?

- Look for Shared Services for **MEM support**.

6. Do you receive B-notices from the IRS at 1099 time, telling you that your vendor name and Tax Identification number do not match their database?

- Look for **Vendor Validation** in Core and Shared Services

7. Do you want to protect yourself from accidentally paying someone that is sanctioned by the Office of Foreign Asset Control (OFAC)?

- Look for **Vendor Validation** in Core and Shared Services
